

ORDINANCE 908

**AN ORDINANCE OF THE TOWN OF OGDEN DUNES, PORTER COUNTY, INDIANA,
FIXING SALARY RATES AND COMPENSATION RATES OF OFFICIALS AND
EMPLOYEES OF THE TOWN OF OGDEN DUNES**

WHEREAS, it is the intention of the Town Council of the Town of Ogden Dunes, Porter County, Indiana to establish compensation rates for officials and employees of the Town of Ogden Dunes; and

WHEREAS, the Town Council of the Town of Ogden Dunes wishes to create a special fringe benefit for certain employees.

NOW THEREFORE, BE IT HEREBY ORDAINED AND ENACTED by the Town Council of the Town of Ogden Dunes, Porter County, Indiana as follows:

SECTION 1: Effective December 22, 2024, the following salary and wage rate schedule is established:

**Town Attorney receives additional compensation which is governed by a separate contract approved by the Ogden Dunes Town Council

*** Eligible for compensatory time in lieu of overtime in the event overtime work is required due to staffing, holiday, or special event service, but not eligible for inspection fees

**** Position split between Street/MVH, Sanitation and Waterworks with same person occupying all positions

*****Any Patrolman (FT or PT) working a Special Event Patrol (as such shall be designated by the Town Council) shall be paid at the rate of \$50.00 per hour, provided that such pay rates shall not be subject to time and one-half.

(Max) – Maximum: the positions above with the term (max) are positions that may be filled at a lower rate than indicated. The rate shown is the maximum hourly rate.

SECTION 2: All regular Full-Time employees of the Town of Ogden Dunes who have served continuously for one (1) year or more as of December 1 of the current year shall receive service pay as follows, payable on the last payroll date in November:

One (1) year but not more than two (2) years:	\$200.00
Two (2) years but not more than five (5) years:	\$400.00
Five (5) years but not more than seven (7) years:	\$600.00
Seven (7) years but not more than nine (9) years:	\$1,000.00
Nine (9) years but not more than twelve (12) years:	\$1,200.00

Twelve (12) years but not more than fifteen (15) years: \$1,500.00
More than fifteen (15) years: \$2,000.00

SECTION 3: This ordinance shall be effective upon its passage and adoption as required by law.
