ORDINANCE NO. 797

AN ORDINANCE OF THE TOWN OF OGDEN DUNES TOWN COUNCIL AMENDING SECTION 52.18 PAYMENT OF CHARGES OF THE OGDEN DUNES TOWN CODE

BE IT AND IT IS HEREBY ORDAINED by the Town Council of the Town of Ogden Dunes that the following amended language replace Section 52.18 Payment of Charges in the Ogden Dunes Town Codes as follows:

Section 1: Section 52.18 Payment of Charges. All bills on the above schedule shall be rendered and due quarterly. A due date shall be set forth in the bill. In the event the bill is not paid by the due date, a 10% late payment fee shall be assessed on all water charges. In addition, a \$27.50 charge for returned checks shall apply plus all bank charges and fees resulting from the returned check. The charge set forth in this section is mandatory for all residential structures in the Town of Ogden Dunes. All charges assessed in accordance with this section are the responsibility of the owner of the property served. All water service shall be arranged with the Town of Ogden Dunes through the property owner of record for each property requiring such service. Quarterly billing will be sent to the property owner of record and may not be sent to or placed in the name of a temporary tenant. It is the responsibility of the property owner of record to supply correct billing address to the Town of Ogden Dunes for property owners living off property.

Section 2: Relief from the provisions of this ordinance may be granted by the Water Works Department for water service upon submission of a proper request. All such requests must be made in writing by the person seeking such relief and must state the special circumstances that the submitter believes would justify relief. The decision to grant such relief shall be determined by the Ogden Dunes Water Board. Decisions on such requests, including the grounds for granting or denying such requests, shall be made of record during a regular meeting of the Water Board.

This ordinance shall be in full force and effect after its adoption by the Ogden Dunes Town Council.

ORDINANCE NO. 798

Section 1: Section 51.34(D) the charge set forth in this section is mandatory for all residential structures in the Town of Ogden Dunes. All charges assessed in accordance with this section are the responsibility of the owner of the property served. All sanitation service shall be arranged with the Town of Ogden Dunes through the property owner of record for each property requiring such service. Quarterly billing will be sent to the property owner of record and may not be sent to or placed in the name of a temporary tenant. It is the responsibility of the property owner of record to supply correct billing address to the Town of Ogden Dunes for property owners living off property.

Section 2: Relief from the provisions of this ordinance may be granted by the Ogden Dunes Town Council for sanitation service upon submission of a proper request. All such requests must be made in writing by the person seeking relief and must state the special circumstances that the submitter believes would justify relief. The decision to grant such relief shall be determined by the Ogden Dunes Town Council for sanitation services. Decisions on such requests, including the grounds for granting or denying such requests, shall be made of record during a regular meeting of the Town Council.
